## Limited Registration Contract For Miniature Poodle Puppy

This Puppy Sale Contract is made \_\_\_\_\_, between G-/ Kennel; Misty Ditges the "Breeder"- hereinafter collectively referred to as "Seller"- and the ("Buyer") \_\_\_\_\_.

In consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as following:

1. Dog: Seller agreed to sell and Buyer agrees to buy the following:

hereinafter referred to as "Dog".

2. Price: The mutually agreeable purchase price shall be \$\_\_\_\_\_. The purchase price shall be paid in full to Seller on or before the dog leaves the sellers possession. There will be a fee of 4% added to all credit card payments.

3. Use: Buyer agrees that intended use of the Dog will be for Pet, Companion or Therapy Animal only and agrees to spay/neuter the Dog at your veterinarian earliest recommendation.

4. Return of Dog: The parties hereto acknowledge that the Dog sold under this contract is unique and cannot be readily replace by another and, thus, Buyer agrees that the Dog will never be placed in a rescue, humane society, or animal services without first contacting Seller. Buyers agrees to return the Dog to the Breeder should Buyer have need to relinquish the Dog **for any reason**.

5. Dog Name: Buyer agrees to register this puppy with AKC within 30 days of transfer of ownership.

6. Representations and Warranties of Seller: Seller represents that the Dog is in good health and has received appropriate medical care, vaccinations, and worming during the period of Seller's ownership and control. Seller will provide Buyer with records detailing any treatment, vaccination and veterinary visits the Dog has received under Seller's care. Seller guarantees that the Dog is free of life-threatening diseases or disabilities for 72 hours after deliver to Buyer. Should life threatening diseases or disabilities be discovered by Buyer within 72 hours after receipt of the Dog, and attested to in writing by a licensed veterinarian, seller will

provide Buyer with a full refund of purchase price upon return of puppy to Breeder by Buyer. Cost of returning puppy to Breeder will be discussed and agreed upon by both parties should this situation arise. Except as otherwise expressly stated herein, the Seller assumes absolutely no responsibility for fees associated with caring for the Dog. No other guarantees are given regarding the health of the Dog beyond the 72-hour evaluation period.

Temperament and size: Seller has done everything possible to give the Dog the best start in life. After purchase Seller makes no temperament guarantees as Seller is no longer a direct influence on future training, socialization, and obedience. Seller will not be held responsible for acts of the Dog due to buyer's negligence. The Seller will not be held responsible for the size of the puppy at maturity. Size can only be estimated and compared to the other sizes in the litter.

7. Limitations on Warranties: EXCEPT AS EXPRESSLY PROVIDED IN THIS AGREEMENT, SELLER MAKES NO OTHER REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, EITHER IN FACT OR BY OPERATION OF LAW, STATUTE, OR OTHERWISE, AND BUYER SPECIFICALLY DISCLAIMS ANY AND ALL IMPLIED OR STATUTORY WARRANTIES INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

8. Limitation of Seller's Liability: Buyer assumes all risk and liability for loss, damage, or injury to persons or property of Buyer or other arising out of use or possession of the Dog. Seller shall not be liable for direct, indirect, special, or consequential damages of any kind arising out of Buyer's use or possession of the Dog.
